

# WIN – for Qatar 2022-Terms and Conditions



## 1. Campaign Period:

The Qatar 2022 World Cup Campaign commences on 01/08/2022 at 12:00AM KWT Time until 30/09/2022 at 11:59PM KWT Time (both dates inclusive) unless notified otherwise.

## 2. Eligibility

- 2.1. All new and existing Visa Credit Cardholders of Burgan Bank credit revolving/Charge Card(s) ("Burgan Bank Cards") issued by Burgan Bank K.P.S.C. are eligible to participate in the Campaign ("Cardholders").
- 2.2. The following persons are NOT eligible to participate in this Campaign:
